

Invitation to Bid for the Procurement of FLAGS AND SIMILAR SUPPLIES FOR THE DEPARTMENT OF FOREIGN AFFAIRS

- 1. The Department of Foreign Affairs, through the authorized appropriations under the FY 2023 General Appropriations Act (GAA) intends to apply the sum of One Million Seven Hundred Sixteen Thousand One Hundred Sixty Five Pesos (Php 1,716,165.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Flags and Similar Supplies for the Department of Foreign Affairs. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Foreign Affairs now invites bids for the "Procurement of Flags and Similar Supplies for the Department of Foreign Affairs", described as follows:

- 3. The Department of Foreign Affairs now invites bids for the above Procurement Project. Delivery of the Goods is stated on the Technical Specifications. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 5. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
- 6. Prospective Bidders may obtain further information from the Department of Foreign Affairs and inspect the Bidding Documents at 2330 Roxas Boulevard, Pasay City, 1300 during 8:00 a.m. to 5:00 p.m.
- 7. A complete set of Bidding Documents may be acquired by interested Bidders on 14 March 2023, from the BAC Secretariat and at https://dfa.gov.ph/transparency-dfa/procurements.

The Department of Foreign Affairs reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
