## Procurement for the Repair, Operation and Maintenance of Sewage Treatment Plant of DFA OCA Aseana from January – December 2024

- 1. The Department of Foreign Affairs, through the authorized appropriations under the FY 2024 National Expenditure Program intends to apply the sum of One Million Five Hundred Thousand Pesos (PhP 1,500,000.00) only, the Approved Budget of the Contract (ABC) to payments under the contract for the **Procurement for the Repair, Operation and Maintenance of Sewage Treatment Plant of DFA OCA Aseana from January-December 2024**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Foreign Affairs now invites bids for the **Procurement for the Repair**, **Operation and Maintenance of Sewage Treatment Plant of DFA OCA Aseana from January-December 2024**, described as follows:

- 4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

Prospective Bidders may obtain further information from the Department of Foreign Affairs and inspect the Bidding Documents at 2330 Roxas Boulevard, Pasay City, 1300 during office hours or from 8:00 a.m. to 5:00 p.m.

- 10. Bid opening shall be on 08 November 2023, Wednesday, 10:00 A.M. via BAC Video Conferencing. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity through online video conference.

The Department of Foreign Affairs reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
