BAC Resolution No. SMC-PB-39-2023

**RESOLUTION RECOMMENDING APPROVAL FOR THE AWARD OF THE
CONTRACT ON THE PROCUREMENT OF HAULING SERVICES TO THE
DEPARTMENT OF FOREIGN AFFAIRS (DFA) TEMPORARY HEADQUARTERS**

WHEREAS, the Department of Foreign Affairs (DFA), through the authorized appropriations under the FY 2024 National Expenditure Program, intends to apply the sum of Twenty-Five Million and Ninety-Three Thousand Pesos (PhP 25,093,000.00) only, being the Approved Budget for the Contract (ABC) for the *Procurement of Hauling Services to the DFA Temporary Headquarters*;

WHEREAS, the ABC is chargeable against the Office of Asset Management and Support Services' FY 2024 Maintenance and Other Operating Expenses;

WHEREAS, on 19 October 2023, the Bids and Awards Committee (BAC) held the *Pre-Procurement Conference* as required by Section 20 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 08 November 2023, the BAC Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the procurement project on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the IRR of RA 9184;

WHEREAS, on 15 November 2023, the BAC held a *Pre-Bid Conference* to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by Airspeed International Corporation, Nonpareil International Freight & Cargo Services Inc., Soonest Global Express Corporation, CBI Freight Forwarder & Courier Express International, GML Cargo Forwarder & Courier Express International, GML Cargo Forwarder and Courier Express International Inc., and K5 Plus Logistics Corp.;

WHEREAS, on 29 November 2023, on the **deadline for the submission and receipt of bids**, as well as the date of **opening** thereof, two (2) bidders submitted their bids namely: F2 Logistics Philippines Inc., and Crown Worldwide, which the BAC determined to be as follows:

Crown Worldwide	Failed to present its Statement of all ongoing contracts as prescribed in GPPB Circular No. 04-2020 and Sec. 23.4.1.4 of the Revised IRR of RA 9184.	Sealed

WHEREAS, the BAC declared *F2 Logistics Philippines Inc.* as having the Single Calculated Bid, and subjected it to **Post Qualification** on 04 December 2023, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the Post Qualification and after careful evaluation, the BAC and the end-user representatives determined that the bid of **F2 Logistics Philippines** was compliant with and is responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, RESOLVE to RECOMMEND the award of the contract on the Procurement of Hauling Services to DFA Temporary Headquarters to **F2 Logistics Philippines Inc.** for having submitted the Single Calculated and Responsive Bid in the amount of **Twenty Million Eight Hundred Thousand Pesos (PhP 20,800,000.00) only**, pursuant to Section 37 of the IRR of RA 9184.






