BAC Resolution No. SMC-PB-51-2023

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT
FOR THE PROCUREMENT OF PURIFIED DRINKING WATER
FROM JANUARY TO DECEMBER 2024**

WHEREAS, the Department of Foreign Affairs (DFA), through the authorized appropriations under the 2024 National Expenditure Program (NEP), intends to apply the sum of One Million Five Hundred Fifty-Two Thousand Three Hundred Twenty Pesos (*Php* 1,552,320.00) only, the Approved Budget for the Contract (ABC) for the Procurement of Purified Drinking Water for FY 2024 with identification number PB-GS-38-2023-EP14;

WHEREAS, the said ABC is chargeable against the respective offices' Maintenance and Other Operating Expenses (MOOE) for Water Expenses FY 2024;

WHEREAS, on 27 October 2023, the Bids and Awards Committee (BAC) conducted a **Pre-Procurement Conference** to discuss the Technical Specifications/Terms of Reference for the procurement project;

WHEREAS, on 05 December 2023, the BAC Secretariat posted for seven (7) consecutive calendar days the **Invitation to Bid** for the Procurement of Purified Drinking Water from January to December 2024 on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 13 December 2023, the BAC held a **Pre-Bid Conference**, to discuss the eligibility requirements and the technical and financial components of the contract to be bid, in which two (2) prospective bidders attended namely, Daco Sales Corporation and Cooler Industries;

WHEREAS, on 27 December 2023, the deadline for the **submission and receipt of bids** as well as the date of opening thereof, only Daco Sales Corporation submitted a bid, which the BAC determined to be as follows:

WHEREAS, the BAC declared **Daco Sales Corporation** as having the Single Lowest Calculated Bid, and subjected it to **Post-Qualification** on 29 December 2023, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents;

WHEREAS, during the post-qualification and after careful consideration, the BAC determined that the bid of **Daco Sales Corporation** was compliant with and is responsive to all the requirements and conditions as specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Purified Drinking Water Supply from January to December 2024 to **Daco Sales Corporation** for having submitted the Single Lowest Calculated and Responsive Bid in the amount of **One Million Five Hundred Forty-Three Thousand Four Hundred Forty-Nine 60/100 Pesos (PhP PhP 1,543,449.60)** only, pursuant to Section 37 of the revised IRR of RA 9184.
