BAC Resolution No. CPM-PB-23-2023

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT
ON DFA CAGAYAN DE ORO PROPERTY RENOVATION AND
REHABILITATION WORKS**

WHEREAS, the Department of Foreign Affairs (DFA), through the authorized appropriations under the Building Fund FY 2022 Continuing Appropriations, intends to apply the sum of ***Eleven Million One Hundred Ninety-Four Thousand Five Hundred Twenty-Five and 6/100 (Php 11,194,525.06) only***, being the Approved Budget for the Contract (ABC) for the ***Procurement DFA Cagayan De Oro Property Renovation and Rehabilitation Works*** (Procurement Project);

WHEREAS, the said ABC is chargeable against FY 2022 Building Fund;

WHEREAS, on 03 March 2023, the Bids and Awards Committee (BAC) in its Resolution CPM-PB-05-2023 declared a failure of bidding for the Procurement DFA Cagayan De Oro Property Renovation and Rehabilitation Works for its failure to present the original documents, and therefore, is not responsive to the requirements set forth in Rule X, 34.3;

WHEREAS, on 17 April 2023, the BAC conducted a ***Pre-Procurement Conference*** to assess the readiness of the Procurement Project by confirming the availability of funds and reviewing all relevant documents in relation to the Procurement Project;

WHEREAS, on 27 April 2023, the BAC Secretariat posted for seven (7) consecutive calendar days the ***Invitation to Bid*** for the Procurement Project on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 04 May 2023, the BAC held the first ***Pre-Bid Conference*** to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by *Duamon Construction and Supplies, Multi-Fold Links Inc., and V.B. Columna Corp.*;

WHEREAS, on 18 May 2023, the deadline for the *submission and receipt of bids as well as the date of opening* thereof, only **WeFix Construction Services Inc.** submitted its bid, which the BAC determined to be as follows:

WHEREAS, during the Opening of Bids, **WeFix Construction Services Inc.** was declared **"compliant" to the technical and financial component**, having the Single Calculated Bid, and was scheduled for **Post-Qualification** on 23 May 2023, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complies with and is responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the Post-Qualification and after careful consideration, the BAC determined that the bid of **WeFix Construction Services Inc.** was compliant with the requirements and conditions specified in the Bidding Documents;

WHEREAS, after its evaluation, the TWG Members determined that the bid of **WeFix Construction Services Inc.** complies with the technical requirements specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the **Procurement DFA Cagayan De Oro Property Renovation and Rehabilitation Works** to **WeFix Construction Services Inc.** for having submitted the Single Calculated and Responsive Bid in the amount **Eleven Million Fifty Six Thousand One Hundred Twenty Three Pesos and 44/100 (PhP 11,056,123.44) only**, pursuant to Section 37 of the revised IRR of RA 9184.


