	<p>To provide VIP transport services to the Lithuanian delegation, participants, and to transport personnel for logistical and administrative support during the visit of the Hungarian FM.</p>

Transportation for the Security of Delegation – Sedan 5. Transportation for the Secretariat – Van 6. Duration of the trip should be twelve (12) hours rendering time, inclusive of sudden excess of hours rendered. 7. Driver should have a valid PH driver’s license and verifiable COVID-19 vaccination certificate. 8. Quoted price should be within PhP 101,800.00 and should include rendering time, as well all taxes, duties and/or levies payable. 9. Bidders should accept a send-bill payment arrangement. 10.
