**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
UNDER SECTION 52.1(b) (SHOPPING) FOR THE PROCUREMENT OF NINE (9)
UNITS OF DESKTOP COMPUTERS WITH SOFTWARE PERIPHERALS FOR THE
OFFICIAL USE OF THE DEPARTMENT OF FOREIGN AFFAIRS (DFA)
MINDANAO**

WHEREAS, the Department of Foreign Affairs Mindanao ("DFA Mindanao") intends to procure nine (9) units of desktop computers with software peripherals for its official use;

WHEREAS, the procurement of nine (9) units of desktop computers with software peripherals for the official use of DFA Mindanao, as listed under Purchase Request No. DFAMIN-2024-07-24, with an Approved Budget for the Contract ("ABC") of *Six Hundred Seventy-Nine Thousand Seven Hundred Sixty-Seven Pesos* (PhP 679,767.00) only, chargeable against Building Fund Program (BFP) FY 2023 Continuing Appropriations is included in the Department's Supplemental Annual Procurement Plan ("SAPP") for FY 2023;

WHEREAS, Section 52.1(b) of the Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Shopping as a method of procurement of goods whereby the procuring entity requests the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualification in the procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding one million pesos (PhP 1,000,000.00);

WHEREAS, Section 52.1(b) of the IRR applies to this procurement based on the email received from the PS-DBM Depot that the items being procured by DFA Mindanao are not available;

WHEREAS, pursuant to Item No. (V)(C)(2)(b)(iii) of Annex "H" of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, a Request for Quotation (RFQ) was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website for at least three (3) calendar days, from 23 July to 26 July 2024;

WHEREAS, in compliance with Item No. (V)(C)(2)(b)(iv), Annex H of the IRR, separate Requests for Quotation ("RFQ") were also sent to at least three (3) potential suppliers/contractors namely: Modernext IT Solutions Corporation; Ultrium Corporation; and Miles Computer Ventures Corporation;

WHEREAS, in response to the solicitation of offers, quotations were received from: Modernext IT Solutions Corporations (Php 493,920.00; Failed; Require payment before delivery and delivery cost was not included); Ultrium Corporation (Php 663,300.00; failed, bidder is not compliant with the Technical Specifications); and **Miles Computer Ventures Corporation**, which submitted the lowest calculated and most responsive quotation in the amount of *Five Hundred Seventy-Four Thousand Two Hundred Pesos* (Php 574,200.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity ("HoPE") resort to Section 52.1(b) (Shopping) as the alternative method of procurement for the procurement of nine (9) units of desktop computers with software peripherals for the official use of DFA Mindanao to **Miles Computer Ventures Corporation**, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




