BAC Resolution No. HO-585-24

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.6 (SCIENTIFIC, SCHOLARLY OR ARTISTIC WORK, EXCLUSIVE TECHNOLOGY AND MEDIA SERVICES) FOR THE PROCUREMENT OF SERVICES FOR THE RAUL SUNICO CONCERT ENTITLED, "MOVING MELODIES: DFA'S TRIBUTE TO 2330"

WHEREAS, the Office of Cultural Diplomacy ("OCD"), is organizing a concert which will be the final cultural activity at the Bulwagang Apolinario Mabini, as a way to bid farewell, temporarily, to the 2330 Roxas Blvd., as it undergoes retrofitting for the next three to four (3-4) years. The concert is a celebration of the many years of stories and memories of the Department of Foreign Affairs ("DFA") personnel before the move to the new DFA offices. The concert will feature piano and chorale performances of music pieces, both Filipino and classical;

WHEREAS, OCD intends to procure services of a contractor that can provide the following services: conceptualize, coordinate and stage a piano and chorale concert featuring selected Philippine music and classical music; produce a concert showcasing Philippine and classical music including program design, stage and venue design; create resource materials such as publication materials (teasers, posters, highlights), playbill, digital content, ad video recordings of the concert; create concert setting; produce recorded and short videos, for the Raul Sunico Concert entitled, "Moving Melodies: DFA's Tribute to 2330" on 04 December 2024;

WHEREAS, the procurement of the services for the Raul Sunico Concert entitled, "Moving Melodies: DFA's Tribute to 2330", with an Approved Budget for the Contract ("ABC") of *Two Million Four Hundred Forty – Three Thousand One Hundred Twenty – Two Pesos and 24/100* (PhP 2,443,122.24) only, chargeable against OUMAIER-CDU's FY 2024 Regular Appropriations MOOE for Other Professional Services, is included in the Department's Supplemental Annual Procurement Plan ("SAPP") for FY 2024;

WHEREAS, Section 53 of the 2016 Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Negotiated Procurement;

WHEREAS, further, Section 53.6 of the said revised IRR can be resorted where Goods, Infrastructure Projects and Consulting Services can be contracted from a particular supplier, contractor or consultant as determined by the Head of the Procuring Entity ("HoPE"), for any of the following requirements, *inter alia*: (a) Work of art; commissioned work or services of an artist for specific artistic skills (e.g. singer, performer, poet, writer painter sculptor, etc.);

WHEREAS, the Bids and Awards Committee ("BAC"), after taking into consideration all relevant factors, finds that the awarding of the procurement of the services for the Raul Sunico Concert entitled, "Moving Melodies: DFA's Tribute to 2330" may be done under Section 53.6(a) of the 2016 revised IRR of RA 9184;

WHEREAS, pursuant to Annex "H" of the 2016 Revised IRR of RA 9184, the End-User shall conduct a market study and determine the probable sources;

WHEREAS, the OCD submitted to BAC the following market study results: Masaya Studio Inc. (did not submit quotation); Para Sa Sining (did not submit quotation); and **Sinematika, Inc.** (PhP 2,428,720.00);

WHEREAS, after conducting a thorough market study, OCD determined that **Sinematika, Inc.** is compliant with the Technical Specifications/Terms of Reference could undertake the project at more advantageous terms in the amount of *Two Million Four Hundred Twenty – Eight Thousand Seven Hundred Twenty Pesos* (PhP 2,428,720.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, **RESOLVE** to **RECOMMEND** to the Head of the Procuring Entity ("HoPE") resort to Negotiated Procurement under Section 53.6 (Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services) as the alternative method of procurement for the procurement of the services for the Raul Sunico Concert entitled, "Moving Melodies: DFA's Tribute to 2330" from **Sinematika, Inc.**, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




