BAC Resolution No. HO-204-24

RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR PROCUREMENT OF VARIOUS TYPES OF WINES FOR THE OFFICIAL USE OF THE OFFICE OF THE SECRETARY

WHEREAS, the Office of the Secretary (“OSEC”) intends to procure various types of wines for its official use;

WHEREAS, the procurement of various types of wines for the official use of the Office of the Secretary, as listed under Purchase Request No. 06-07424, with an Approved Budget for the Contract (“ABC”) of *Four Hundred Thousand Pesos* (PhP 400,000.00) only, chargeable against OSEC’s FY 2024 MOOE under Representation Expenses, is included in the Department’s Annual Procurement Plan for FY 2024;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (“IRR”) of Republic Act (“RA”) No. 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex “H” of the 2016 revised IRR of RA 9184, a Request for Quotation (“RFQ”) was posted on the Philippine Government Electronic Procurement System (“PhilGEPS”) website for at least three (3) consecutive days, starting from 23 July to 26 July 2024;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex “H” of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: ESTATEWINE Inc.; Bottlezone Corporation; and Yats Wine Cellar;


WHEREAS, in response to the solicitation of offers, quotations were received from: Yats Wine Cellar (PhP 151,400.00; *failed, bidder is not compliant with technical specifications*); AF Consumer Goods Trading (PhP 394,933.00; *failed, bidder is not compliant with technical specifications*); and **ESTATEWINE INC.**, which submitted the lowest calculated and responsive quotation in the amount of *Three Hundred Ninety-Eight Thousand Five Hundred Eighteen Pesos* (PhP 398,518.00) only;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity resort to Negotiated Procurement under Section 53.9 (Small Value Procurement) as the alternative method of procurement for the procurement of to **ESTATEWINE INC.**, subject to the abovementioned requirements, and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




