BAC Resolution No. EBB-PB-03-2024

**RESOLUTION RECOMMENDING AWARD OF CONTRACT THROUGH
NEGOTIATED PROCUREMENT (TWO FAILED BIDDINGS) FOR THE
PROCUREMENT OF LEASE OF MOTOR VEHICLES FOR THE
DEPARTMENT OF FOREIGN AFFAIRS FOR THE PERIOD
JUNE TO DECEMBER 2024**

WHEREAS, the Department of Foreign Affairs (DFA), through the authorized appropriations under the FY 2024 General Appropriations Act (GAA), intends to apply the sum of Twenty-Two Million Six Hundred Five Thousand Six Hundred Twenty-Five Pesos (PhP 22,605,625.00) only, being the Approved Budget for the Contract (ABC) for the Lease of Motor Vehicles for the DFA for the period June to December 2024 (Procurement Project);

WHEREAS, the said ABC is chargeable against various Offices' FY 2024 Maintenance and Other Operating Expenses (MOOE) under Rents–Motor Vehicles;

WHEREAS, the Department of Budget and Management, per its Authority to Rent Motor Vehicle/s (ARMV) No. D3-24-00001 dated 14 November 2023, authorized the DFA to lease forty-four (44) motor vehicles for more than fifteen (15) consecutive days for FY 2024 amounting to Thirty-Eight Million Seven Hundred Fifty-Two Thousand Five Hundred Pesos (PhP 38,752,500.00) only;

WHEREAS, on 16 April 2024, the Bids and Awards Committee (BAC) issued BAC Resolution RLT-PB-02-2024 declaring a failure of bidding for the Lease of Motor Vehicles for the Department of Foreign Affairs for the period June to December 2024;

WHEREAS, on 13 May 2024, the BAC issued BAC Resolution EBB-PB-02-2024 declaring a failure of bidding for the Lease of Motor Vehicles for the Department of Foreign Affairs for the period June to December 2024;

WHEREAS, the BAC conducted a mandatory review of the terms, conditions, specifications, and cost estimates of the Procurement Project after two failed biddings;

WHEREAS, on 16 May 2024, the BAC Secretariat posted for seven (7) consecutive calendar days the **Notice of Conduct of Negotiated Procurement under Section 53.1 (Two Failed Biddings) for the Procurement of Lease of Motor Vehicles for the DFA for the period June to December 2024** on the DFA and PhilGEPS websites, and conspicuous places within the premises of the DFA, in accordance with Part IV(E) of Annex H of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, the BAC also invited three (3) suppliers for negotiations to ensure effective competition, namely: ANIS Transport; Enterprise Car Lease Philippines Inc.; and A&W Tours En Transport Corporation;

WHEREAS, on 24 May 2024, the BAC conducted a **Negotiation Meeting** to discuss the eligibility requirements and the technical and financial components of the contract to be bid, which was attended by A&W Tours En Transport Corporation;

WHEREAS, on 27 May 2024, the deadline for the **submission and receipt of best and final offers**, as well as the date of opening thereof, only A&W Tours En Transport Corporation submitted its offer, which the BAC determined to be as follows:

WHEREAS, the BAC declared A&W Tours En Transport Corporation as having the Single Calculated Quotation, and scheduled it for **Verification of Eligibility Documents** on 29 May 2024 to determine whether it complies with and is responsive to all the requirements and conditions specified in the Notice of Negotiated Procurement;

WHEREAS, during the Verification and after careful consideration, the BAC determined that the bid of A&W Tours En Transport Corporation was compliant with and is responsive to all the requirements and conditions specified in the Notice of Negotiated Procurement;

WHEREAS, the end-user representative determined that the technical requirements submitted by A&W Tours En Transport Corporation were compliant with the requirements and conditions specified in the Notice of Negotiated Procurement;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Lease of Motor Vehicles for the Department of Foreign Affairs for the period June to December 2024 to **A&W Tours En Transport Corporation** for having submitted the Single Calculated and Responsive Quotation in the amount of **Twenty-Two Million One Hundred Twenty Thousand Pesos (PhP 22,120,000.00) only**, pursuant to Section 53.1 of the revised IRR of RA 9184.
