

AGREEMENT FOR THE SECURITY SERVICES FOR THE DEPARTMENT OF FOREIGN AFFAIRS (1 MAY TO 31 DECEMBER 2024)

KNOW ALL MEN BY THESE PRESENTS:

This **AGREEMENT** for the procurement of security services for the Department of Foreign Affairs (hereinafter, the **AGREEMENT**), entered in Pasay City, Philippines, on 30 APR 2024 between the:

DEPARTMENT OF FOREIGN AFFAIRS, (hereinafter, the **PROCURING ENTITY**), with principal office address at 2330 Roxas Boulevard, Pasay City, 1300 represented by the Undersecretary, and Head of the Procuring Entity (HOPE), **ANTONIO A. MORALES**,

and

NC LANTING SECURITY SPECIALIST AGENCY (hereinafter, the **CONTRACTOR**), a company duly organized and existing under and by virtue of the laws of the Philippines, as evidenced by the submitted Certificate of Business Name Registration issued by the Department of Trade and Industry on 25 June 2023, valid until 25 June 2028, attached as **ANNEX A**, with principal office address at 218 Malvar St., Ayala Alabang, Muntinlupa City, Fourth District, National Capital Region (NCR) represented by Ms. **NIMFA DELA CRUZ LANTING**, who is duly authorized to enter into this **AGREEMENT** as the Company Proprietress and General Manager.

WITNESSETH:

WHEREAS, the **PROCURING ENTITY** invited bids for the **SECURITY SERVICES FOR THE DEPARTMENT OF FOREIGN AFFAIRS COVERING THE PERIOD OF EIGHT (8) MONTHS FROM MAY TO DECEMBER 2024** and has accepted a bid by the **CONTRACTOR** to provide said services in the sum of **Ninety-Three Million Three Hundred Ninety-Nine Thousand Nine Hundred Ninety-Six Pesos and Thirty-One Centavos (PhP93,399,996.31)** only (hereinafter, the **CONTRACT PRICE**), inclusive of all applicable taxes and other lawful charges.

NOW, THEREFORE, for and in consideration of the foregoing premise, the **PARTIES** agree as follows:

In case of conflict or inconsistencies between or among any of provisions of this Agreement and the documents annexed hereto, the provisions contained in this Agreement, the Technical Specifications (Annex F), and the Special Conditions of Contract (Annex H) shall be controlling.

2. The **CONTRACTOR** shall provide the services to the **PROCURING ENTITY** within the period prescribed in the Terms of Reference (**ANNEX F**) for a period of eight (8) months or from 1 May to 31 December 2024.
3. For and in consideration of the delivery of the performance of services, the **PROCURING ENTITY** shall pay the **CONTRACTOR** the above-mentioned **CONTRACT PRICE**. The



terms of payment shall be in accordance with the provision of Section 8 of **TECHNICAL SPECIFICATIONS (ANNEX F)**.
