**BAC Resolution No. EBB-PB-01-2024**

**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE  
PROCUREMENT OF VARIOUS FLAGS AND SIMILAR SUPPLIES FOR THE  
DEPARTMENT OF FOREIGN AFFAIRS**

**WHEREAS**, the Department of Foreign Affairs (DFA), through the General Appropriations Act FY 2024, intended to apply the sum of Four Million Five Hundred Seventy-Eight Thousand Four Hundred Twenty Pesos (Php 4,578,420.00) only being the Approved Budget for the Contract (ABC), chargeable against OAMSS, HRMO, and various Foreign Service Post's FY 2024 Maintenance and Other Operating Expenses (MOOE), for the ***Procurement of Various Flags and Similar Supplies for the Department of Foreign Affairs***;

**WHEREAS**, on 08 March 2024, the Bids and Awards Committee (BAC) Secretariat conducted a ***Pre-Procurement Conference*** for the aforementioned procurement to ensure that the procurement is in accordance with the Annual Procurement Plan (APP), and to discuss the technical specifications of the project;

**WHEREAS**, on 11 April 2024, the ***Invitation to Bid*** was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

**WHEREAS**, on 19 April 2024, the BAC held a ***Pre-Bid Conference*** to discuss the eligibility requirements as well as the technical and financial components of the contract to be bid which was attended by Atlas Super Flags;

**WHEREAS**, on 03 May 2024, the ***deadline for the submission and receipt of bids*** as well as the date of the ***opening*** thereof, the following bids were received and rated as follows:

**WHEREAS**, the BAC declared ***Atlas Super Flags*** as having the Single Calculated Bid, and subjected it to ***Post-Qualification*** on 06 May 2024, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was

responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, during the post-qualification and careful consideration, the BAC determined that the bid of **Atlas Super Flags** was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

**WHEREAS**, the Office of Asset Management and Support Services (OAMSS), the End-User for this procurement, has likewise confirmed that the bid of **Atlas Super Flags** was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

**NOW, THEREFORE**, we, the Members of the Bids and Awards Committee, unanimously **RESOLVE** to **RECOMMEND** the award of the Contract for the procurement of *Various Flags and Similar Supplies for the Department of Foreign Affairs* to **Atlas Super Flags** for having submitted the Single Calculated and Responsive Bid in the amount of **Four Million Five Hundred Seventy-One Thousand Eight Hundred Pesos (Php 4,571,800.00)** only, pursuant to Section 37 of the revised IRR of RA 9184.
