RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE PROCUREMENT OF LEASE OF BAGGAGE SCANNER AND WALKTHROUGH METAL DETECTORS FOR THE DEPARTMENT OF FOREIGN AFFAIRS (DFA) TEMPORARY OFFICE

WHEREAS, the Department of Foreign Affairs (DFA), through the General Appropriations Act FY 2024, intended to apply the sum of Two Million Five Hundred Thousand Pesos (PhP 2,500,000.00) only being the Approved Budget for the Contract (ABC), chargeable against OAMSS FY 2024 Maintenance and Other Operating Expenses (MOOE) for Rents – Equipment, for the Procurement of Lease of Baggage Scanner and Metal Detectors for the Department of Foreign Affairs (DFA) Temporary Office;

WHEREAS, on 14 November 2024, the Bids and Awards Committee (BAC) conducted a *Pre-Procurement Conference* for the aforementioned procurement to discuss the technical specifications of the project and ensure that the procurement is in accordance with the Annual Procurement Plan (APP);

WHEREAS, on 15 November 2024, the *Invitation to Bid* was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 25 November 2024, the BAC held a *Pre-Bid Conference* to discuss the eligibility requirements as well as the technical and financial components of the contract to be bid which was attended by MCL Technology Solutions;

WHEREAS, on 29 November 2024, a Supplemental Bid Bulletin No.1 for the aforementioned procurement was posted on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, providing supplemental information for the aforementioned project, in accordance with Section 21.5 of the IRR of RA No. 9184;

WHEREAS, on 09 December 2024, the *deadline for the submission and* receipt of bids as well as the date of the *opening* thereof, only MCL Technology Solutions submitted its bid, which the BAC determined to be as follows:

WHEREAS, the BAC declared *MCL Technology Solutions* as having the single Calculated Bid, and subjected it to **Post-Qualification** on 12 December 2024, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents:

WHEREAS, on 12 December 2024, during the post-qualification and careful consideration, the BAC determined that the bid of *MCL Technology Solutions* was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, the Intelligence and Security Unit of the Office of the Secretary (ISU-OSEC), the End-User for this procurement, has likewise confirmed that the bid of *MCL Technology Solutions* was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the Contract on the Procurement of Lease of Baggage Scanner and Metal Detectors for the Department of Foreign Affairs (DFA) Temporary Office to MCL Technology Solutions for having submitted the Single Calculated and Responsive Bid in the amount of Two Million Four Hundred Ninety-Nine Thousand Eight Hundred Forty Pesos (Php 2,499,840.00) only, pursuant to Section 37 of the revised IRR of RA 9184.
