**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT ON THE
PROCUREMENT OF TELEVISIONS FOR THE OFFICIAL USE OF CONSULAR
OFFICES**

WHEREAS, the Department of Foreign Affairs (DFA), through the General Appropriations Act FY 2024, intended to apply the sum of Two Million One Hundred Eighty-Seven Thousand Three Hundred Twenty Pesos (Php 2,187,320.00) only being the Approved Budget for the Contract (ABC), chargeable against OCA's FY 2024 Maintenance and Other Operating Expenses (MOOE) under Communications Equipment (Semi-Expendable), for the ***Procurement of Televisions for the Official Use of Consular Offices***;

WHEREAS, on 22 October 2024, the Bids and Awards Committee (BAC) Secretariat conducted ***Pre-Procurement Conference*** for the aforementioned procurement to ensure that the procurement is in accordance with the Annual Procurement Plan (APP), and to discuss the technical specifications of the project;

WHEREAS, on 28 October 2024, the ***Invitation to Bid*** was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, on 05 November 2024, the BAC held a ***Pre-Bid Conference*** to discuss the eligibility requirements as well as the technical and financial components of the contract to be bid which was attended by Pronet Systems Integrated Network Solution, Inc., Asahi Design Centre Inc., and Likha Eco Traders Inc.;

WHEREAS, on 06 November 2024, a ***Supplemental Bid No. 1*** for the aforementioned procurement was posted for seven (7) consecutive calendar days on the DFA website, Modernized PHILGEPS, and conspicuous places within the premises of the DFA, providing supplemental information for the aforementioned project, in accordance with Section 21.5 of the IRR of RA No. 9184;

WHEREAS, on 19 November 2024, the ***deadline for the submission and receipt of bids*** as well as the date of the ***opening*** thereof, the following bids were received and rated as follows:

Pronet Systems Integrated Network Solution, Inc.	Compliant	One Million Three Hundred Twenty-Eight Thousand Seven Hundred Five Pesos and Eighty-Eight Centavos (PhP 1,328,705.88)


WHEREAS, the BAC declared *Pronet Systems Integrated Network Solution, Inc.* as having the lowest Calculated Bid, and subjected it to **Post-Qualification** on 22 November 2024, pursuant to Section 34.2 of the IRR of RA 9184, to determine whether it complied with and was responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, during the post-qualification and careful consideration, the BAC determined that the bid of *Pronet Systems Integrated Network Solution, Inc.* was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, the Office of Consular Affairs (OCA), the End-User for this procurement, has likewise confirmed that the bid of *Pronet Systems Integrated Network Solution, Inc.* was compliant and responsive to all the requirements and conditions specified in the Bidding Documents;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously **RESOLVE** to **RECOMMEND** the award of the Contract on the *Procurement of Televisions for the Official Use of Consular Offices to Pronet Systems Integrated Network Solution, Inc.* for having submitted the Single Calculated and Responsive Bid in the amount of **One Million Three Hundred Twenty-Eight Thousand Seven Hundred Five Pesos and 88/100 (Php 1,328,705.88)** only, pursuant to Section 37 of the revised IRR of RA 9184.


