## BAC Resolution No. EBB-PB-14-2024

RESOLUTION RECOMMENDING, BY REFERENDUM, THE AWARD OF CONTRACT OF EMERGENCY REHABILITATION OF DFA OCA-ASEANA'S SEWAGE TREATMENT PLANT (STP) WITH ONE-YEAR OPERATION AND MAINTENANCE

WHEREAS, the Department of Foreign Affairs (DFA), through the authorized appropriations under the Building Fund Program (BFP) FY 2023 Continuing Appropriations under Buildings, intends to apply the sum of Eleven Million Two Hundred Thirty Two Thousand Pesos (Php 11,232,000.00) only being the Approved Budget for the Contract (ABC) for the Procurement of Emergency Rehabilitation of DFA OCA-ASEANA's Sewage Treatment Plant (STP) with One-Year Operation and Maintenance (Procurement Project);

WHEREAS, on 10 July 2024, the Bids and Awards Committee (BAC) conducted a Pre-Procurement Conference to discuss the Scope of Work for the Procurement Project;

WHEREAS, on 19 July 2024, the BAC Secretariat posted for seven (7) consecutive calendar days the *Invitation to Bid* for the Procurement Project on the DFA and PhilGEPS websites, and conspicuous place within the premises of the DFA, in accordance with Section 21.2 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, on 26 July 2024, Supplemental Bid/Bulletin No.1 was issued to move the schedule of the Pre-Bid Conference from 10:00 A.M. to 1:30 P.M.;

WHEREAS, the *Pre-Bid Conference* was attended by three (3) prospective bidders, namely: Bon Wastewater Solutions Corp.; Ariescor Water Inc.; and EEMC Construction and Development Corp.;

WHEREAS, on 29 July 2024, Supplemental Bid/Bulletin No.2 was issued to provide clarification on the Scope of Work particularly Item VII.3 of Contractor's Qualifications, "Class B" documents in the Checklist of Requirements, and the requirement for a valid PCAB license;

WHEREAS, on 30 July 2024, Supplemental Bid/Bulletin No.3 was issued to provide clarification on the Scope of Work, particularly Item IV.2 (Treatment and Performance Efficiency);

**WHEREAS**, on 08 August 2024, Supplemental Bid/Bulletin No.4 was issued to move the schedule of the Opening of Bids on 09 August 2024 from 10:00 A.M. to 2:00 P.M.;

WHEREAS, on 09 August 2024, the deadline for the submission and receipt of bids as well as the date of opening thereof, only EEMC Construction and Development Corporation submitted its bid for the said Procurement Project, the details of which are as follows:

WHEREAS, the BAC declared EEMC Construction and Development Corporation as having the Single Calculated Bid, and subjected it to *Post-Qualification* on 13 August 2024, pursuant to Section 34.2 of the IRR of RA No. 9184;

WHEREAS, during the post-qualification of bids and after careful evaluation, the BAC determined that the bid of EEMC Construction and Development Corporation was compliant with and responsive to all the requirements and conditions specified in the Bidding Documents;

WHEREAS, on 20 August 2024, the end-user unit requested for the Head of the Procuring Entity's (HOPE) approval to extend the Post-Qualification process for a maximum period of fifteen (15) calendar days pursuant to Sec. 38.4 of 9184's IRR to conduct an ocular inspection of one of EEMC Construction and Development Corps' completed projects and office facility located in Puerto Princesa, Palawan;

WHEREAS, the HOPE approved the said extension for Post-Qualification in order to verify the technical capacity of the bidder to undertake the Procurement Project;

WHEREAS, the end-user unit, after thorough review and verification, submitted its findings and determined that EEMC Construction and Development Corporation is compliant to the Scope of Work, Bid Offer Form / Bill of Quantity, Detailed Unit Price Analysis (DUPA), Single Largest Completed Contract, Office Facility, and the Personnel Data Sheet (Manpower to be deployed) for the project;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, unanimously RESOLVE to RECOMMEND the award of the contract for the Procurement of Emergency Rehabilitation of DFA OCA-ASEANA's Sewage Treatment Plant (STP)

with One-Year Operation and Maintenance to EEMC Construction and Development Corporation for having submitted the Single Calculated and Responsive Bid in the amount of Ten Million Nine Hundred Eighty-Nine Thousand Nine Hundred Pesos (PhP 10,989,900.00) only, pursuant to Section 37 of the revised IRR of RA 9184.
