Back Ground	The DFA-OVS acquisition of Fiber Optic Internet connections is needed in view of the large volume of e-mails expected in the implementation of Republic Act No. 10590, an Act Amending RA No. 9189, entitles "An Act Providing for a System of Overseas Absentee Voting by Qualified Citizens of the Philippines Abroad, Appropriating Funds Therefor and For Other Purposes".
Objective	To facilitate the immediate transmission of communications and receipt from OVS to Foreign Service Posts (FSPs) and back especially during Overseas Voter's Registration and Election period.
