

CONTRACT AGREEMENT FORM

THIS AGREEMENT made this 10th day of March between **Department of Foreign Affairs - OFFICE OF EUROPEAN AFFAIRS (OEA)** of the Philippines (hereinafter called "the Entity") of the one part and **DLCL Transport** with registered business address at **402 Kayumanggi St., Plainview, Mandaluyong City, Philippines** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Quotations for certain goods and ancillary services, viz., **DFA - Lease of Motor Vehicles for the Official Visit to the Philippines of Slovenian Foreign Minister H.E. Tanja Fajon, 10-12 March 2025 with RFQ# BAC2025-009** and has accepted a Small Procurement bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Seventeen Thousand Seven Hundred Ninety Five Pesos Only (P117,795.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The Quotation Form and the Cost Distribution submitted by the Bidder shall be deemed to form and be read and construed as part of this Agreement;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

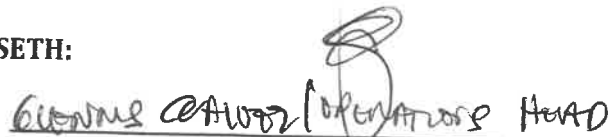
