RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR PROCUREMENT OF CATERING SERVICES FOR THE PHILIPPINES-UNITED NATIONS (PH-UN) DIALOGUE AND THE 2ND JOINT STEERING COMMITTEE OF THE UNITED NATIONS SUSTAINABLE DEVELOPMENT COOPERATION FRAMEWORK (UNSDCF), 05 MARCH 2025

WHEREAS, the Office of United Nations and International Organizations ("UNIO") intends to procure catering services for the PH-UN Dialogue and the 2nd Joint Steering Committee of the UNSDCF, 05 March 2025 for its official use;

WHEREAS, the Procurement of Catering Services for the PH-UN Dialogue and the 2nd Joint Steering Committee of the UNSDCF, 05 March 2025, with an Approved Budget for the Contract ("ABC") of *One Hundred Fifty Thousand Pesos* (PhP 150,000.00) only, chargeable against UNIO's FY 2025 MOOE under Representation Expenses, is included in the Department's Annual Procurement Plan for FY 2025;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations ("IRR") of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex "H" of the 2016 revised IRR of RA 9184, a Request for Quotation ("RFQ") was posted on the Philippine Government Electronic Procurement System ("PhilGEPS") website for at least three (3) consecutive days, starting from 28 February to 03 March 2025;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex "H" of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: UCPB Group Multi-Purpose Cooperative; Funmania Inc., and Bizu Catering Studio;

WHEREAS, in response to the solicitation of offers, quotations were received from: UCPB Group Multi-Purpose Cooperative (PhP 105,600.00; failed, quotation did not comply with the technical specifications); Bizu Catering Studio (PhP 192,000.00; failed, quotation did not comply with the technical specifications and quoted price exceeds the ABC); and **Funmania Inc.**, which submitted the lowest calculated and responsive quotation in the amount of *One Hundred Eight Thousand Pesos* (PhP 108,000.00) only;


