RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE LEASE OF MOTOR VEHICLES FOR THE VISIT TO THE PHILIPPINES OF UNITED KINGDOM SECRETARY OF STATE FOR FOREIGN, COMMONWEALTH, AND DEVELOPMENT AFFAIRS THE RT HONORABLE DAVID LAMMY, MP, ON 08 MARCH 2025

WHEREAS, the Office of European Affairs (“OEA”) intends to lease motor vehicles for the visit to the Philippines of United Kingdom Secretary of State for Foreign, Commonwealth, and Development Affairs the RT Honorable David Lammy, MP, on 08 March 2025 ;

WHEREAS, the lease of motor vehicles for the visit to the Philippines of United Kingdom Secretary of State for Foreign, Commonwealth, and Development Affairs the RT Honorable David Lammy, MP, on 08 March 2025, with an Approved Budget for the Contract (“ABC”) of *Eighty-Four Thousand Nine Hundred Pesos* (PhP 84,900.00) only, chargeable against OEA’s FY 2025 MOOE under Representation Expenses, is included in the Department’s Annual Procurement Plan for FY 2025;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (“IRR”) of Republic Act (“RA”) No. 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (PhP 1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, pursuant to Item No. (V)(D)(8)(b)(iii) of Annex “H” of the 2016 revised IRR of RA 9184, a Request for Quotation (“RFQ”) was posted on the Philippine Government Electronic Procurement System (“PhilGEPS”) website for at least three (3) consecutive days, starting from 28 February to 03 March 2025;

WHEREAS, in compliance with Item No. (V)(D)(8)(b)(ii), Annex “H” of the IRR, RFQs were sent to at least three (3) potential suppliers/contractors, namely: Royal Fleets; VPI Cars Manila; and DLCL Transport;

WHEREAS, in response to the solicitation of offers, a quotation was received from **DLCL Transport**, which submitted the single calculated and responsive quotation in the amount of *Eighty-Three Thousand Eight Hundred Fifty Pesos* (PhP 83,850.00) only;


NOW, THEREFORE, we, the Members of the Bids and Awards Committee of the Department, RESOLVE to RECOMMEND to the Head of the Procuring Entity resort to Negotiated Procurement under Section 53.9 (Small Value Procurement) as




