The Office of Fiscal Management (OFM) Angklung Ensemble is a musical group that contributes to the interest of public service, and promotes cultural diplomacy and the conduct of foreign affairs. The OFM Angklung Ensemble performed during the DFA's 115th Anniversary, ASEAN's 46th Anniversary, and official visits of Foreign Ministers from various states. It is committed to perform in future official events of the DFA.

I respectfully recommend that funds in the amount of Php 179,000.00, to be sourced from the Passport Revolving Fund (PRF), be provided for the gala costume of the musicians, tuning of the bamboo instruments, and purchase of musical supplies.
