

**AGREEMENT FOR THE 2014 INTEGRATED LOCAL AND GLOBAL HEALTHCARE COVERAGE
FOR DFA PERSONNEL**

KNOW ALL MEN BY THESE PRESENTS:

This Contract Agreement for the 2014 Integrated Local and Global Healthcare Coverage for DFA Personnel, (hereinafter, the AGREEMENT), entered into in Pasay City, Philippines, on **FEB 11 2014**, 2014 between the:

The **DEPARTMENT OF FOREIGN AFFAIRS**, (hereinafter, the **PROCURING ENTITY**), with principal office address at 2330 Roxas Blvd., Pasay City, Metro Manila, represented by its Undersecretary for Administration and Head of the Procuring Entity (HOPE) Honorable Rafael E. Seguis,

and

UNITED COCONUT PLANTERS LIFE ASSURANCE CORPORATION (COCOLIFE) (hereinafter, the **CONTRACTOR**), is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at Cocolife Building 6807 Ayala Avenue, Makati City, represented by MR. FRANZ JOIE D. ARAQUE, who is duly authorized to enter into this Agreement pursuant to the Secretary's Certificate dated 13 January 2014, a copy of which is attached as ANNEX A and made an integral part of this Agreement.

WITNESSETH:

WHEREAS the **PROCURING ENTITY** invited bids for the 2014 Integrated Local and Global Healthcare Insurance Coverage for DFA personnel, and has accepted a bid by the **CONTRACTOR** for the supply of said goods and services in the sum of Four Hundred Five Million Two Hundred Eighty Two Thousand One Hundred Sixty-Two Pesos (Php 405,282,162.00) (hereinafter called "the Contract Price"), inclusive of all taxes and other lawful charges.

NOW, THEREFORE, for and in consideration of the foregoing premises, the **PARTIES** agree as follows:

1. The definitions found in the General Conditions of Contract (GCC) and Special Conditions of Contract contained in the Philippine Bidding Documents for Procurement of Goods issued by the Government Procurement Policy Board (GPPB) are deemed incorporated in this AGREEMENT.
2. The following documents are attached and made integral parts of this AGREEMENT:
 - 2.1 Bid Form and Price Schedule submitted by the Supplier (ANNEX B)
 - 2.2 Terms of Reference (ANNEX C)
 - 2.3 Sworn Statement of Compliance with the Terms of Reference/Technical Specifications (ANNEX D)
 - 2.4 Standard Policy Contract (ANNEX E)
 - 2.5 Administrative Agreement between Cocolife and Global Benefits Group (ANNEX F)
 - 2.6 Notice of Award dated 27 December 2013 (ANNEX G)
3. The **CONTRACTOR** shall provide immediate local health/medical coverage for DFA officers, employees and dependents based in Manila and the Regional and Satellite Offices, and global health/medical coverage for DFA officials, employees and dependents in the Foreign Service Posts (FSPs) beginning 01 January 2014 pending the issuance of the Notice to Proceed. The **CONTRACTOR** guarantees the availability and reliability of all healthcare and insurance coverage to be supplied and provided and shall make good at its own expense and account, any defect or breach that may be discovered by the **PROCURING ENTITY**
4. For and in consideration of the performance of services, the **PROCURING ENTITY** shall pay the **CONTRACTOR** the above-mentioned Contract Price. The terms of payment shall be in accordance with the provisions stated in the Standard Policy Contract, which is attached and made an integral part of this Agreement.


